



## Douglas E. Edgington

August 14, 1959 - January 8, 2019

It is with great sadness that the family of Doug Edgington announces that he came to his "end of watch" on Tuesday, January 8, 2019 at the age of 59 years. Doug will be remembered lovingly by his wife of 29 years, Beth, who, as he always said, was "the love of his life" and his sons Robbie and Danny, of whom he was tremendously proud, who are also both "brothers in arms" with him as they carry on their dad's legacy of serving in the U.S. Marine Corps. Doug will also be missed and remembered lovingly by his parents, Jane Edgington and Jack (Katy) Edgington, his brother Judson (Stacey) Edgington, his sisters Jill (Hank) Pyles and Dee Dee (Tim) Roby, his niece Janey (Billy) Sites, nephew John Pyles and many others including aunts, uncles, cousins, friends and colleagues. Doug was preceded in death by his grandparents Laura and Harley "Gene" Edgington, and Gertrude and Alonzo Granger, and his mother- and father-in-law John and Edie Lusher.

Everyone who knew Doug knows what a big, generous heart he had and that he was "mission oriented"; thus, his primary mission in life was to serve others. Doug loved the USA and proudly served his country in the Marines as an 0311A in the Infantry, and in the U.S. Army Reserve as a Criminal Investigator and Protective Service Agent, retiring from his 27 year military career in the Reserves as a Chief Warrant Officer 3. Doug was dedicated to his local community, as well, and dedicated his life to the citizens close to home serving as a first responder throughout his civilian career. Doug retired from the Franklin County Sheriff's Office at the rank of Major with 32 years of

service. Of course, although he was retired, Doug could not sit idle, so he joined the Hocking County Sheriff's Office, where he served as a deputy and polygraph examiner, while holding a full-time position as a deputy bailiff for security in the Franklin County Municipal Courts, and working as a range instructor at LEPD Firearms & Range.

Throughout his military career, Doug fulfilled assignments including Infantryman, Fire Team Leader, Squad Leader, Platoon Guide, Platoon Sergeant, Military Policeman, Criminal Investigator, Assistant Special Agent in Charge, Mission Special Agent in Charge, and Team Chief. In addition to his work in the U. S. Army Reserves, Doug was deployed twice as a result of the terrorist attacks on 9/11, serving two years on active duty from September 11, 2001 through October 31, 2003. During his first deployment, he carried out Protective Service missions throughout the world. His second deployment had him stationed in Iraq. Throughout Doug's civilian careers, he served as a volunteer firefighter with the Jackson Twp. Fire Dept. in Grove City, OH, then joined the Franklin County Sheriff's Office where he worked in many divisions, including corrections, patrol, court services, and the detective bureau. His zeal to serve and protect led him to take on additional responsibilities at the Sheriff's Office that included service as a rescue diver, SWAT officer, Tactical officer, medic, Patrol Division Training officer, and instructor with Ohio Peace Officer Training Academy. In addition to his law enforcement training, he also held credentials as a Certified Law Enforcement Manager, Certified Jail Manager, and Polygraph Examiner. Again, because of his dedication to service, he earned numerous awards for his civilian work, including:

Doug's love for serving extended into his personal life, too, especially when it came to his sons Robbie and Danny. As a Boy Scout, himself, when he was young, Doug realized the value of Scouting and had a passion for it. Not only did he encourage his own sons to get involved in Boy Scouts, he was actively involved for many years, too, serving as, first, an Assistant Scoutmaster, then Scoutmaster for BSA Troop 295 in Upper Arlington. In addition to guiding his own sons to the rank of Eagle Scout, he mentored many other boys from the troop, encouraging them to earn their Eagle Scout rank, as well. In typical Doug fashion, he assumed additional roles within Scouting, with one of the most notable being that of furthering Catholic Scouting by maintaining the position of Religious Emblem Coordinator. He held qualifications to be a merit badge counselor for many of the merit badges that Scouts can earn, as well. Doug was also involved in some of the adult scouting programs, especially the BSA Woodbadge program. As with other elements of his life, Doug earned recognition and awards for his volunteer service to the Boy Scouts of America, including:

Numerous "mentor" pins presented to him from Scouts in the troop.

The "Bridge Builder Award", which is designed to recognize the adult leader who has bridged the gap between the adult and youth members of Scouting. A nominee for this award must have rendered noteworthy service to boys or Scouting at their unit or district level.

The "James E. West Fellowship Award" for individuals who make a significant contribution to their local council endowment trust fund.

Doug is a graduate of Grove City High School and Ohio Dominican University, where he also earned awards for his work earning his Bachelor's degree in the criminal justice field.

As would be no surprise to anyone who knew Doug, he embraced his Irish heritage and was a member of several organizations, including the Shamrock Club, Ancient Order of Hibernians, the Knights of Columbus, and the St. Timothy Men's Club. Doug's hobbies included scouting, camping, reading and traveling with his wife and sons.

In his own words, and in his spirit and love of serving others, Doug's recent life mission and philosophy was, "I plan on leaving the US Army Reserve upon reaching my mandatory retirement date, and I aspire to perform in whatever role I can best serve the citizens of the United States, and the Great State of Ohio."
