Eugene L. Bulgozdy, 87, of Dublin, passed away peacefully Thursday, November 3, 2011. Gene was born in Cleveland, Ohio to the late Michael and Elizabeth Bulgozdy, attended Chaney High School in Youngstown, received his bachelors degree from Youngstown State University, and his masters degree in physical chemistry from Washington State University. He served honorably in the United States Army Air Force during World War II. Gene began his business career with General Electric Co. in 1952 and retired in 1990 as a Vice President of Ashland Chemical Company. After retiring, Gene volunteered as a tutor with Dublin Public Schools and in 2010 was inducted into the Dublin Schools Hall of Fame in recognition of his service. He was a faithful parishioner of St. Brigid of Kildare Catholic Church and a charter member of The Country Club at Muirfield Village. Gene was a loving husband, devoted father, friend to children, cheerful host, an avid golfer, and one who always had a kind word for everyone and was a fixture in his neighborhood walking his dog, Killer.
