“ *TRIBUTE BY ISAAC ANNAN RIVERSON - A friend and Attorney*

I first met Keith in September 2013 in Accra after he was introduced to me by his business partner Albert Tabirih and right from that very day we became great friends and brothers. I subsequently became his Attorney here in Ghana and we started working together to help build his business. What a good guy to work with?

The news of his untimely death here in Accra came to me as a great shock. Just few days before on 20th May, I had visited him in his hotel room after my return from Europe. We discussed wide range of issues, not the least how to revive his business here in Ghana which had suffered some setbacks in the recent past. He was very hearty as he lied on his bed and ushered me into a sofa. He jokingly "flashed" in my face a bundle of local currency and with such optimism and seriousness in his eyes, he told me "Isaac, I've got a lot of cash now so we shall soon be back on track". We both laughed over this and agreed to meet the next weekend to plan our next line of action.

Keith showed no signs of ill-health at all and the message I subsequently sent to his mum Shirley in the US was that "Keith is okay health-wise".

On the morning of 27th May, 2015 I was in a meeting when I received a call from an informant with the news that my good friend Keith had become frail overnight and wasn't taking his food. I immediately asked the informant to rush him to the hospital and wait for me to meet them there. I also received an email from Shirley who wanted to verify the same information she had received from the same informant.

*Less than an hour later while I was waiting to know which hospital he had been taken, I got a call that my dear friend and brother had been pronounced dead on arrival at the Police Hospital in Accra. **WHAT A SHOCK. MY FRIEND WAS GONE TOO SOON!***

I still cannot believe that this great man with a determined spirit to explore business opportunities here in Ghana is no more with us! His sudden death is a huge blow and loss to me personally and one thing I will always remember him for was his PASSION FOR SUCCESS!

As we say here in Ghana in the local Twi language,

"BROTHER KEITH, DAMIRIFA DUE! DAMIRIFA DUE! DAMIRIFA DUE DUE DUE!!!

May his Gentle Soul Rest in Perfect Peace!
