



## Louis E. Gerber

January 31, 1930 - February 17, 2024

Louis E. Gerber of Worthington, Ohio, died peacefully on 2-17-24 surrounded by his family. He was born on 2-1-1930 in Ravenna, Ohio, to the late Louis E. and Viola (Brechbill) Gerber. Lou served in the Army from 1948-1950 and remained in the Reserves until retiring as a Major in 1968. Lou attended Kent State University and The Ohio State University College of Law receiving his law degree in 1957. He was a Law Clerk to the Hon. Lester Cecil U.S.D.C. Judge (Dayton, OH). Lou joined the firm of Knepper, White, Richards & Miller in 1958 as a trial attorney, becoming a partner in 1961 until his retirement from the successor firm in 1995. He was a Fellow in the American College of Trial Lawyers, a member of the International Association of Defense Counsel, and the Defense Research Institute

Lou was predeceased by his sister and brother-in-law, Rheta and Richard Deal. He is survived by his loving wife Sherry of 40 years, his children Gwen (Van) Gerber, Amy Gerber, Andy (Belinda) Gerber, Rob (Alda) Sicilian, Stacey Sicilian, Tony (Amanda) Sicilian, Kevin (Pam) Sicilian, and Brian (Susie) Sicilian, ten grandchildren and several nieces and nephews.
