



Paul "Geep" Gregory

Paul "Geep" Gregory, age 62, died Wednesday at Kobacker House following an extended illness. Paul was born June 27, 1952 in Columbus, Ohio. Paul was a graduate of The Ohio State University and earned his Masters Degree at Kent State. He was the Chief of Watercraft for the Ohio Dept. of Natural Resources from 1983 to 1995 and after retirement, a substitute high school science teacher for Columbus Public Schools. At the time of his death, he was a PhD candidate at Antioch University.

Paul is survived by his father Warren Gregory; partner Kathy Janoski; children, Kristen Gregory (Rogier Paalvast), and Kolin Gregory; grandson, Kingston Johnson; sisters, Patrice Gregory (Tim Anderson), and Deborah (Ralph) Thompson; brothers, Marcus Gregory and Steve Gregory; niece Lena Thompson and other close relatives and friends. He was preceded in death by his mother, Mollye (Cornett) Gregory; daughter, Katrina Gregory; ex-wife, Mary Pat Kington; nephew, Justin Dickson; and best friend Vince Canzani. “ Paul Gregory founded the Ohio Voter Rights Alliance for Democracy to serve as a leading litigant to stop the theft of American Presidential elections. Such litigation was filed on August 31, 2006 along with a motion for an injunction, granted a few days later, against the destruction of the Ohio 2004 ballots.

This historic King-Lincoln case had been preceded by:

- 1) A election day Federal Court order to keep the polls open in the Columbus inner-city precincts,
 - 2) Public hearings in the major metropolitan areas for citizens to testify about their problems in the election;
 - 3) An Ohio Supreme Court challenge to the 2004 election by voters, inspired by Rev. Jesse Jackson's invitation to join as plaintiffs, and to “be like those who marched from Selma to Montgomery with Martin Luther King Jr”;
 - 4) A staff report by the US House Judiciary Committee of its investigation of the 2004 presidential election and two Congressional hearings leading up to Congresswoman Stephanie Tubbs Jones’ of Cleveland challenge of the Ohio Electors on January 6, 2005;
 - 5) After the plaintiffs dismissed their Ohio Supreme Court challenge following the electoral college vote, the Alliance for Democracy seeking to intervene and try the Ohio Democratic Party election day case against the Ohio Secretary of State;
 - 6) The funding of RH Phillips PhD, to analyze those ballots and document the fraud that had reversed the outcome of the election in Ohio; and
 - 7) In June of 2006, Robert F. Kennedy, Jr. graphically documenting in the Rolling Stone Magazine the systemic fraud as had been reported by the Ohio Statehouse press corps at the time.
- Paul personally interacted with the press on the court-house steps on the morning of the filing. Paul's stature as a former section chief in the State government lent credibility to the court filing, and helped create the momentum for the injunction against destruction of the ballots, as well as Rainbow-PUSH joining as a plaintiff in the first amended complaint filed on October 9, 2006.*

In early 2008 Witness to a Crime by RH Phillips was published

containing a CD-ROM with actual photographs of ballots. Paul was the client representative, joined briefly by Rev. Otis Moss, Jr. from the board of Rainbow-PUSH, in the November 2008 Cleveland, Ohio federal court proceeding, in which Judge Solomon Oliver ordered the deposition of Karl Rove's IT guru, Mike Connell, to go forward on the day before the November 2008 Presidential election. Connell's company, GovTech, had contracted with Blackwell, not only to present 2004 election results on the web, but also through its subcontractor SmarTech, to mirror the entire election function of the Secretary of State's office in the 2004 election on the Republican Party's computer center in Chattanooga, TN.

Mike Connell had been set up, by the contractual relationship with SmarTech, to take the fall for the theft of the U.S. Presidency in the 2004 election. Paul's observation, that Connell's face turned beet red when the judge ruled that his deposition would go forward. This revealed that Connell may have feared that he had been set up to take the fall for the defeat of President Obama in the 2008 election as well by SmarTech using the program designed by Connell to bypass the security protocols of the State computer's Oracle database.

On Monday, Connell explained: "SmarTech was a subcontractor in my contract, but I did not put them there." Connell thus linked Karl Rove to the systemic massive rigging of the 2004 Presidential election.

*Paul didn't just earn a PhD in leadership, but a place in the still unfolding history of restoring American democracy as well.
